1. Company Overview

Multireisen Deutschland MRD GmbH is a Berlin-based business-to-business (B2B) travel-technology company and travel consolidator. Its core product is the **MULTIREISEN booking engine** (also marketed as one2reisen), a white-label online platform that lets travel agencies, agency chains, cooperations, tour operators and OTAs search and book flights, hotels, package tours, car rentals, cruises, transfers and related services under wholesale conditions.

The company positions itself as “the biggest international B2B travel consolidator headquartered in Germany.” Marketing materials state the brand has refined its booking engine since 2003 and cite integration of 650–850+ suppliers across flights (Global Fares, NDC, Direct Connect), hotels, car rentals, transfers, packages, cruises, trains, buses and activities. Reach figures on company sites have grown over time and read as self-reported marketing claims.

Ahmed Sherif is a Berlin-based entrepreneur active across three sectors — travel technology, real estate and sports education. He founded the company in 2013 (as Hottours GmbH) and ran it as sole managing director for about eleven years, until September 2024, building it into an international B2B travel consolidator. Since 2022 he has diversified into real estate (Semonex, Immonex) and, from mid-2024, a non-profit football-training academy (DFA). Personal biographical detail (age, nationality, education, pre-2013 career) is not published; his LinkedIn (“MRD Sherif”) is login-gated.

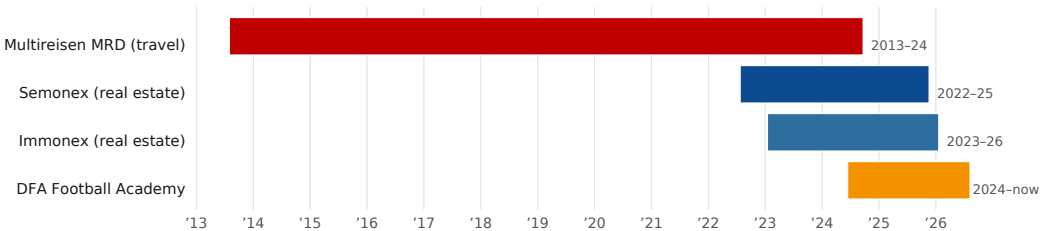

The real-estate entities use Kirschenallee 20, 14050 Berlin; at Immonex he was succeeded by Jurijs Mackans on 19 Jan 2026.

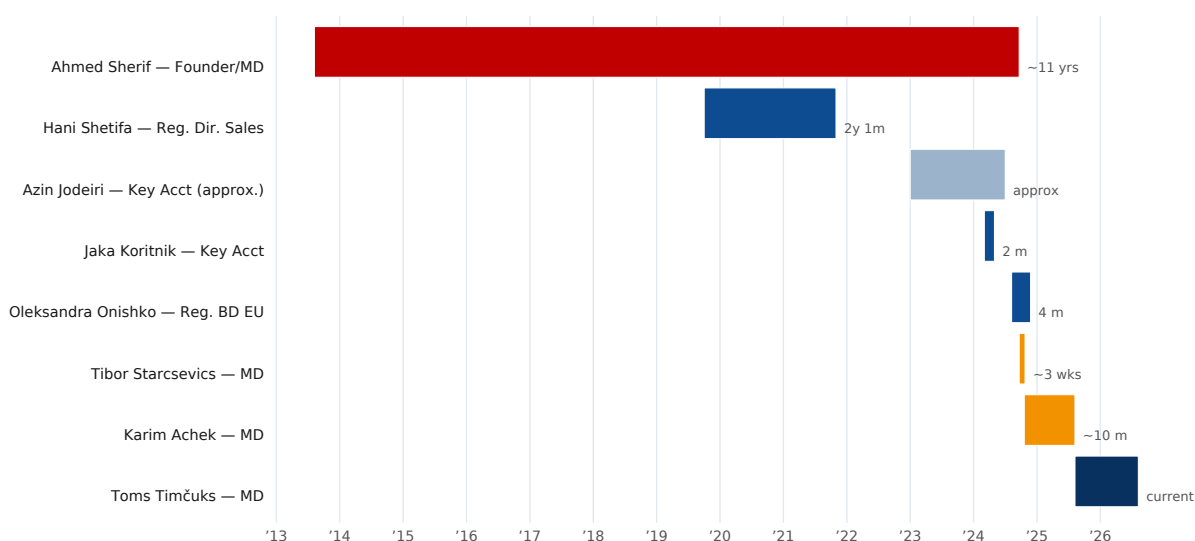

8.1 Linked domains & hosting footprint

Web-intelligence data ties several domains to the same operator through a shared Google Analytics ID and common hosting — useful for mapping the group's online estate:

- **Shared Google Analytics ID UA-52946236** links **hottours.de**, **hottours.ua** and **one2fly.com** (detected Mar 2016 – Oct 2017) — consistent with the company's original ‘Hottours’ identity.
- **multireisen.com overlap/attribute domains:** multireisen.com, multireisen.at, onlinebistro.com.ua, hottours.de, hottours.ua, one2fly.com.
- **Hosting:** multireisen.com resolved to IP 54.76.100.223 from Nov 2015 to Mar 2025 (~9 years, 4 months) — a long, stable hosting history.

Interpretation: the ‘Hottours’ and ‘one2fly’ domains predate/parallel the Multireisen brand and share tracking + hosting, reinforcing that they are part of the same founder's estate (the GmbH was itself registered as Hottours GmbH in 2013).

9. Reputation — Reviews & Feedback

The statements below are **third-party opinions** published by reviewers on public platforms, reproduced with attribution — individual allegations / experiences, not verified facts. Multireisen has a small review footprint, weighted negative on customer-service platforms.

Customer reviews — [Trustpilot \(multireisen.com\)](#)

Approximately 12 reviews; predominantly negative themes reported:

- No response to inquiries after payment / after opening a B2B account.
- Billing dispute: a ticket-change fee quoted at \$10 allegedly charged as \$170.
- A travel agent alleged a hotel reservation was cancelled without reason, with a refund requested since October 2024 and not received.
- One reviewer called it “a fraud company” and claimed the managing director and team had become unreachable.
- Support described as “really useless” and slow to respond.

Positive note: at least one reviewer praised the sales team and reported a good offer. The company has posted replies to some complaints (e.g., referencing availability slots and API request handling).

Employee reviews — [Glassdoor](#)

- Very few reviews. Themes: “Poor management and lack of support” and “lack of communication between teams and leadership.”

Because the review samples are small (single digits to ~12), they indicate complaint patterns rather than a statistically representative picture.

Google reviews — analysis (attributed allegations)

Google Maps reviews reinforce the Trustpilot pattern and add specifics. All items below are **reviewers' allegations, not proven facts**; the company has publicly disputed several and threatened defamation action. Note the “Mr. Ahmed” referenced in 2024 complaints post-dates his registered MD exit.

- **Crisis cluster, Oct/Nov 2024:** multiple agents (Ali Al-Foudari, Megress Voyage, Farhad Ebrahimzadeh, M Rashid, Masoud Esmaeeli) allege bookings mass-cancelled and refunds never paid — coinciding with the Sep 2024 MD change (e.g. booking ref MRD325337D4B2U, Plaza Inn Doha).
- **Large alleged sums:** Farhad ~€14k bookings + €25k deposit; Tariq Alsammarraie ~€25k (lawsuit); Deluxe Tourism €14k; airline refunds allegedly reclaimed “without notifications.”
- **Named parties:** GM “Mr. Ahmed” described as unreachable / “outside Germany”; Account Manager **Azin Jodeiri** criticised for urging an **€18,000** booking-engine purchase instead of a refund.
- **Long-running pattern (6-7 yrs):** recurring non-refunds, unresponsive support, high upfront engine pricing with no returns, and disputes escalating to lawsuits (European judiciary).
- **Company responses:** defensive/legalistic, citing supplier rules and threatening to pass “defaming” cases to its “Law House”; one reply surfaced the email key.t@multireisen.com (Head of Key Account Manager Dept).
- **Positives exist:** a few reviewers praised the sales team, net prices and profits (e.g. ‘H S’, furkan genç).

- **Register-confirmed:** founding date, name change, capital increases, full MD history, address, VAT ID, and the founder's Immonex directorship.
- **Provided but not independently re-verified:** Semonex, DFA Football Academy and IIDC roles; individual LinkedIn staff and their titles.

- **Not publicly accessible:** LinkedIn / Bayt profile contents (login-gated); detailed financials, revenue, employee counts, shareholder lists (paywalled at North Data / Creditreform / D&B;); live Trustpilot pages (JavaScript-rendered; browser session unavailable).
- **Not confirmed:** specific GDS partnerships; exact official brand colour codes; current shareholding of Ahmed Sherif after his 2024 MD exit.

Running four companies at once — one sharing the Multireisen office address — reads more like a caretaker arrangement than a dedicated turnaround appointment.

12.2 Semonex anomaly (correction to §4)

- Semonex Investment GmbH (HRB 244377 B) is at **Friedrichstraße 171, 10117 Berlin** — not the Kirschenallee real-estate address; register industry code is ‘correspondence / news agencies’, not real estate.
- Owned **100% by Rafal Wedzicki**; Ahmed Sherif was a hired managing director, not an owner.
- Exit discrepancy: this profile shows an exit ~Nov 2025, but a 2025 Creditreform extract reportedly still lists Sherif as MD — verify via a chronological register extract.

12.4 Where the staff went (decline signal)

Senior, verifiable former staff have moved to direct competitors or left Germany: Hani Shetifa → Saudi Arabia (SRA Solutions / FareFocus, per dossier); Oleksandra Onishko → Bookimed; Jaka Koritnik → Smoobu; Mina Monier → Emerging Travel Group (Cairo); Remon Beshay → Tourico Egypt Travel (Cairo). Notably, an **IBE Travel** cluster has formed: **Tibor Starcsevics** (ex-German MD) now lists IBE Travel Solution Kft. (Hungary) and **Alaa Khallad** is at IBE Travel S.R.O. (Prague) — suggesting IBE Travel is a common landing spot for ex-Multireisen people. No new Multireisen leadership hires have been publicly announced.

12.5 Critical open questions

- Does Ahmed Sherif still hold shares in Multireisen? (ownership determines ongoing influence) — order the shareholder list.

- Karim Achek (ex-MD Oct 2024–Aug 2025): zero public footprint since exit — current status unknown.
- Semonex exit-date discrepancy (register vs Creditreform).
- Is multireiseneg.com (Egypt) still operational? Is one2fly.pl still group-owned?
- Backgrounds of Rafal Wedzicki (Semonex owner) and Jurijs Mackans (took over Immonex Jan 2026).
